How to use:

Enter quantity of product ordered, multiply by price, record in Sub Total Column.

Example 6 Twiggy at 2.25 would be $6 \times 2.25 = \$13.50$

Or

24 feet of 24AWG Shooter wire would be $24 \times .18 = \$4.32$

When finished add all the entries in the Sub Total columns, example from above $\$13.50 + \$4.32 = \$17.82$

Record your answer in the Grand Total Box.

To calculate shipping use the directions below:

All Shipping is USPS ground with delivery confirmation Priority Mail or Overnight is prohibited.

If your Grand Total is

\$.01 to \$35.00 shipping will be \$8.00

\$35.01 to \$100.00 shipping will be \$12.00

\$100.01 to \$200.00 shipping will be \$18.00

\$200.01 to \$400.00 shipping will be \$25.00

Anything over \$400.00 shipping will be \$45.00

Texas State Sales Tax is collected on any shipment addressed inside the State of Texas, unless you are exempt if this applies record your State Sales Tax ID Number in the space allowed. Add the Grand Total and the Shipping Charges; enter the sum into the Total From Above Box. To calculate sales tax multiply the sum in the Total From Above Box by .0825

Enter your sales tax due in the Total Sales Tax Due Box

Example from above Your Grand Total is \$17.82, and the shipping charges are \$8.00 so $\$17.82 + \8.00 is \$25.82 so $\$25.82 \times .0825 = \2.13015 , round up to next penny for a total of \$2.14 due in Texas State Sales Tax.

Add the total from above and the Texas sales tax due to get your Amount due.
